

NE-ASCE Member, Aaron Grote, Attends ASCE Annual Conference

The last week in October, I had the opportunity to participate in the 2005 ASCE Annual Civil Engineering Conference held in Los Angeles. The conference was a three day event with a Younger Member Pre-Conference Program held on the first day.

The Younger Member Program consisted of four presenters and an open forum discussion. The presentations varied in subject matter from the increased use of technology in engineering today, to the importance of communication skills in young engineers, to keys to developing strong leadership skills for the future. The focus was on how to ensure that young engineers will be prepared for the changing role of the civil engineer in the future.

The open forum consisted of a four engineer panel who were CEO's of their respective companies. The setting allowed the panel to give their background stories and share some of their experiences with the younger crowd. The panel then took questions from the audience. This was one of the most interesting parts of the conference for myself because it really gave me an idea of the drive and ambition of these highly successful men.

The second and third days were the actual Annual Conference. The conference was broken up into different lectures and open forums that one could attend. Though Governor Arnold Schwarzenegger was invited to the Opening Plenary Session he was not able to attend. A highlight of the conference included Lt. General Robert Van Antwerp of the US Army as the keynote speaker at the visionaries luncheon. The General is the former LA District Commander in the U.S. Corps of Engineers and is presently the head of recruiting for the Army. His stories and insights on a variety of topics from the War in Iraq to continuing education for engineers was interesting and motivational.

The conference also included presentations on water and transportation projects in the LA and Southern California area. The importance on maintaining the ports and transportation to and from those ports was highlighted by local City of Los Angeles Engineers. There were also presentations on the drinking water demand in the Los Angeles area and the projects intended to meet that growing demand for drinking water. The conference was ended with one of three different tours people could go on. The tours were the Transportation Tour featuring the port, Water Tour #1 focusing on the Water Supply to Los Angeles, and the Water Tour #2 focusing on the Orange County water recycling projects.

ASCE Testifies Before Senate; Releases Preliminary Report on Levee System Failure During Hurricane Katrina

On Nov. 2, technical assessment teams from ASCE and University of California, Berkeley jointly released the Preliminary Data Report on the Performance of the New Orleans Levee Systems in Hurricane Katrina. The report details observations made from Oct. 3-14 when the teams conducted onsite inspections and gathered data on the 17th Street Canal, London Avenue Canal and Industrial Canal levee breaches, among others in New Orleans. ASCE assessment team leader Peter G. Nicholson, Ph.D., P.E., M.ASCE, associate professor of Civil and Environmental Engineering and Graduate Program chair at the University of Hawaii, testified before the U.S. Senate Committee on Homeland Security and Governmental Affairs concerning the team's observations.

Nicholson recommended preparing the New Orleans levee system for the next hurricane season. He said ASCE believes Congress should enact a National Levee Inspection and Safety Program modeled on the successful National Dam Safety Program. The levee program, he said, "should include a national inventory of levees, particularly those that protect large, heavily populated urban areas." He encouraged Congress to establish an independent advisory panel responsible for envisioning the future of the Gulf Coast and proposing ways to begin the rebuilding efforts. Nicholson addressed commonly observed issues such as: the role construction materials played in the degree of damage caused to different parts of the levee system; the frequent presence of "transitions" between different sections of the levees and the problems they caused; and how soil instabilities appear likely to have been responsible for failure of the wall systems at two of the levee breeches.

NOMINATIONS BEING ACCEPTED NOW FOR THE 2006 YOUNG GOVERNMENT CIVIL ENGINEER OF THE YEAR AWARD

For Demonstrated Leadership Potential in and for Significant Contributions to Public Service Engineering

This Award is presented annually to a distinguished young civil engineer employed in the public sector. The National Award Winner will receive a plaque at a session to be determined at the 2006 ASCE Annual Conference.

Other outstanding nominees may be recognized with Certificates of Commendations. Certificates of Commendation will be presented at the Younger Member Leadership Symposium at the 2006 ASCE Annual Conference.

Nominees must be a member of ASCE, age thirty-five years or less on December 31, 2005, an engineer of recognized leadership potential, employed full-time in the public sector for a minimum of five (5) years as of December 31, 2005, and presently employed in the U.S. public sector. E.I.T. certification is required of all candidates.

Engineers who have received a Zone Young Government Civil Engineer Award or a Certificate of Commendation in the past may apply for the National Award provided they meet all criteria. However, they will not be eligible to receive a Certificate of Commendation for the current award year.

Qualifications of the award nominees will be judged on the following:

- X Excellent performance that has demonstrated leadership potential in public sector civil engineering
- X Evidence of high character and professional integrity
- X Civic and humanitarian activities (community service)
- X Outstanding contributions to ASCE

Completed nomination forms must be returned to ASCE <u>NO LATER THAN FEBRUARY 1, 2006</u> in order to be eligible for the award.


